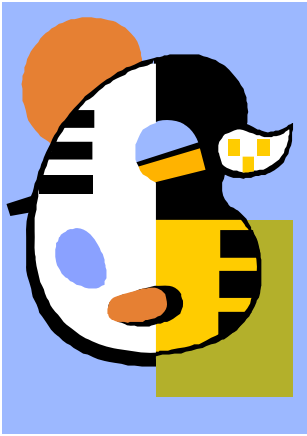

 - ❖ **Exhibitors will be juried for quality as well as number of artisans within same category.**
 - ❖ **Indoor spaces are approximate in size. Outside spaces will easily accommodate a 10’x10’ tent.**
 - ❖ **Exhibitors are responsible for a neat and decorative booth appearance.**
 - ❖ **Check-in and set-up will be:**
 - **Friday, May 28th from 3pm – 8pm**
 - **Saturday, May 29th , from 7am – 8am. All vehicles must be removed before 8am on Saturday.**
 - ❖ **All exhibitors are required to remain set-up and not remove any merchandise until after 4pm on Saturday.**
 - ❖ **Parking will be available for exhibitors only in designated area. Exhibitors may not park in lot by Wishing Spring Gallery to allow for customers.**
 - ❖ **Exhibitors are responsible for their own sales and sales tax.**
